VOCATIONAL INDUSTRY PROFESSIONAL (VIP) PLACEMENT

Mandatory Vocational Placement program designed to enrich students' educational experience through practical, real-world engagement.



- 40 weeks and requiring a commitment of 16 hours per week (Face-to-face or online or combination of both)



- Students have the flexibility to **“bring your own”** (BYO) Vocational Placement Host (possible employers), allowing for a personalised experience that aligns with their career aspirations and interests.



- This program pairs students with an Industry Vocational Placement Host providing an invaluable opportunity to apply theoretical knowledge in a professional setting connecting to real community or organisation partners.

The primary objectives of this placement are skills development, networking, and enhanced employability. Through hands-on experience, students will refine their professional skills, build meaningful industry connections, and significantly boost their job readiness, giving them a competitive edge in the job market.

This mandatory placement is a pivotal component of the Envirotech Education curriculum, ensuring students not only learn but also experience the realities of their chosen field.

SUBCLASS 485 – Temporary Graduate Visa

Post–Vocational Education Work Stream

International students who have completed at least 92 weeks of studies on a Student Visa Subclass 500 in Australia, highly related to their nominated occupation, may be able to apply for the Post–Vocational Education Work Stream visa (Subclass 485).

The Subclass 485 visa allows graduating students under 35 years of age (for most countries, except Hong Kong and British nationals) who meet all the criteria (age, skills, English, health, and character criteria and other) to live, study, and work in Australia currently for the duration of 18 months. Graduates may be eligible to continue with further skilled or employment visa pathways, temporary or permanent.

This visa provides student graduates that completed 92 weeks of highly relevant study to a nominated occupation the time to accumulate professional work experience, pass the English requirements and a skill assessment for their further visa pathway. During this visa duration, students may work and travel without limitation and create skilled work visa pathways:



1. Professional Work Experience



2. Sufficient English Level



3. Complete Process of their Skills Assessment

✓ You must be under 35 years of age unless you are a Hong Kong or British national.	✓ Meet the character requirement.
✓ Have an eligible visa.	✓ Sign the Australian values statement.
✓ Meet the Australian study requirement.	✓ Have no debt to the Australian government
✓ Have a passport from a specified country or this level of English language.	✓ Not have had a visa cancelled or a previous application refused
✓ Meet the health requirement	✓ Have adequate health insurance.
