SKILLED PATHWAY: SUBCLASS 485 GRADUATE WORK STREAM

Envirotech Education provide three pathways and packages for students graduate visa: Sustainability, Marine Conservation and Commercial Cookery.

The 485 Visa is for international students who apply shortly after graduating with skills and qualifications that are relevant to **specific high priority occupations, representing labour shortage, required in Australia.**

This visa lets you live, study and work in Australia temporarily, and if further conditions are met (e.g. employment, English, under 50 years of age, etc.), graduates may be eligible to continue with further skilled or employment visa pathways.

Currently, international **students** who studied on a Student Visa Subclass 500 in Australia over 92 weeks in courses that are **highly related to their nominated occupation**, accumulated required **professional work experience**, met age, skills, English, health, and character criteria may apply for the Visa Subclass 485 under the GRADUATE WORK STREAM for occupations listed as priority skills.

This visa provides student graduates that completed 92 weeks of highly relevant study to a nominated skills occupation the time to accumulate professional work experience, pass the English requirements and a skill assessment for their further visa pathway. During this visa duration, students may work and travel without limitation and create skilled work visa pathways:



1. Professional work experience



2. Sufficient English level



3. Complete process of their skills assessment

- ☒ Complete minimum 92 weeks of highly relevant studies to your nominated occupation on a student visa.
- ☒ Graduated from higher education degree at the nominated occupation in an Australian recognised university or college.
- ☒ Satisfy the minimum AQF for your occupation.
- ☒ Be under 50 years of age.
- ☒ Hold an eligible visa and held a student visa in the last 6 months
- ☒ Have a qualification relevant to an occupation on the skilled occupation list
- ☒ Applied for a skills assessment for skilled occupation list
